INTRODUCTION

Fei Tian College's Early College Program offers qualified high school students the opportunity to concurrently enroll at Fei Tian College and earn college credit while still in high school.

1. The Early College Program (ECP) is a partnership program between Fei Tian College (FTC) and participating high schools.
2. Applicants must be students currently enrolled in a participating high school.
3. Admission into ECP is based on a review of the completed application and any requested supporting material.
4. Admitted students will be automatically registered as non-matriculated FTC students for the semester indicated in their application.
5. Students in ECP are expected to comply with all FTC policies in effect at the time of their participation.
6. For each ECP student an official transcript will be created at FTC, which will become part of the student's permanent educational record.
7. For international students in F-1 visa status: *Before* the start of classes, students must provide their high school International Student Advisor with their official FTC course schedule in order to ensure compliance with Federal regulations on maintaining a full course of study.
8. Continuing participation in ECP is contingent on the student's maintaining good standing and making satisfactory academic and artistic progress.
9. Any student may be terminated from ECP if the College determines that the student's participation has caused interference to regular course instruction or the learning environment of matriculated students at FTC.

STUDENT INSTRUCTIONS

1. Prospective applicants must consult their high school Guidance Counselor and their FTC Academic Advisor, and obtain their written authorization in order to apply for ECP.
2. Applicants must submit a completed FTC ECP Application/Registration Form and any requested supporting material to the FTC Office of Admissions and Records in order to be considered for admission to ECP.
